ORDINANCE NO. 13285

AN ORDINANCE CLOSING AND ABANDONING A PORTION OF THE UNOPENED RIDGEWAY AVENUE OFF THE 6200 BLOCK OF WESTRIDGE ROAD, AS DETAILED ON THE ATTACHED MAP, SUBJECT TO CERTAIN CONDITIONS.

SECTION 1. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That a portion of the unopened Ridgeway Avenue off the 6200 block of Westridge Road, as detailed on the attached map, be and is hereby closed and abandoned:

Abandonment of an unopened and unnumbered portion of Ridgeway Avenue beginning at the northwest corner of Lot 2, Block 4, Third Reamended Plat of the Ridgeway Land Company Addition to St Elmo, Plat Book 7, Page 26, ROHC, thence southeastwardly and southwestwardly some 1100 feet to the south most corner of Lot 5, Block 5 of said plat. Said avenue separates Lot 2, Block 4, and Lots 1 thru 5 of Block 5 of said plat from Lot 48, Final Plat of Lot 47 and 48, and Revised Lots 4 and 5, Being a Revision of Lots 4, 5, and 47, Block 7 Ridgeway Land Company's Addition to Saint Elmo, Plat Book 99, Page 28, ROHC and Lots 6 thru 8 and Lots 40 thru 46, Block 7, Third Reamended Plat of the Ridgeway Land Company Addition to St Elmo, Plat Book 7, Page 26, ROHC. Tax Map Nos. 167B-N-023 thru 025, 026.03, 030 thru 033 and 039.

<u>SECTION 2</u>. BE IT FURTHER ORDAINED, That this abandonment shall be subject to the following conditions:

- 1) The applicant shall obtain necessary permits and approvals from the City of Chattanooga Land Development Office as required for any subsequent construction work. Council action for this item does not constitute a permit for construction work.
- 2) Subject to the retention of full-width utility easement(s) as required by said utilities, including, but not limited to City of Chattanooga Public Works and EPB, as attached and in the location specified on the utility cards attached with this Ordinance.
- This abandonment is contingent upon the following two (2) actions taking place within one hundred eighty (180) days after the approval of this abandonment. Otherwise, the subject right-of-way shall revert back to a public right-of-way:
 - a. The applicant shall dedicate a public access easement at least fifteen (15) feet wide along the existing Hawkins Ridge footpath using the existing footpath as the center line of the easement.
 - b. The applicant shall dedicate a portion of two (2) parcels owned by the applicant (Tax Map Nos. 167B-N-009 and 167B-N-036) as right-of-way to extend Edelweiss Street to the intersection of Westridge Road and Alton Street as shown in the attached exhibit and deed that right-of-way to the City of Chattanooga.

SECTION 3. BE IT FURTHER ORDAINED, That this Ordinance shall take effect two

(2) weeks from and after its passage.






