Logan, Jr. a member of the Electric Power Board to serve a term of office to expire April 15, 2009, or on a date thereafter upon his successor being appointed, elected and qualified; and

WHEREAS, the Mayor of the City of Chattanooga has approved and confirmed the appointment, as shown by Exhibit B attached hereto;

WHEREAS, under the provisions of Chapter 455, Private Acts of the General Assembly of the State of Tennessee, 1935, as amended, when a term of appointment of a member shall have expired or otherwise becomes vacant, the vacancy shall be filled by appointment made by the remaining members of said Board, subject to the confirmation and election by the Mayor and City Council of the City of Chattanooga, Tennessee; and

WHEREAS, the appointment of Warren E. Logan, Jr., as a member of the Electric Power Board of Chattanooga (sometimes herein "Electric Power Board") expired April 15, 2004, and Mr. Logan has continued his office as a member of the Electric Power Board until a successor is appointed and qualified.

NOW, THEREFORE, BE IT RESOLVED, BY THE ELECTRIC FOWER BOARD OF CHATTANOOGA that the remaining members of said Board do hereby appoint Warren E.
