A RESOLUTION AUTHORIZING BRUCE CASE, PRESIDENT CONSTRUCTION CONSULTANTS. OF TO USE TEMPORARILY THE CITY'S RIGHT-OF-WAY BETWEEN THE 7100 BLOCK OF LEE HIGHWAY AND SNOW HILL ROAD TO BUILD A CONCRETE RETAINING WALL WITH PILINGS THAT WILL EXTEND A MAXIMUM OF EIGHT FEET (8') IN THE CITY'S RIGHT-OF-WAY, AS SHOWN ON THE DRAWINGS ATTACHED HERETO AND MADE A PART REFERENCE, SUBJECT HEREOF BY TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That Bruce Case, President of Construction Consultants (hereinafter referred to as "Temporary User") be and is hereby permitted to use temporarily the City's right-of-way between the 7100 block of Lee Highway and Snow Hill Road to build a concrete retaining wall with pilings that will extend a maximum of eight feet (8') into the City's right-of-way, as shown on the drawings attached hereto and made a part hereof by reference.

BE IT FURTHER ORDAINED, That said temporary usage shall be subject to the following additional conditions:

- 1. Owner to make an application with the City Planning Agency for the abandonment of said right-of-way along with a plat for recording.
- 2. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
- 3. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.

INDEMNIFICATION AGREEMENT

For and in consideration of the granting of the temporary usage of the City's right-of-way between the 7100 block of Lee Highway and Snow Hill Road to build a concrete retaining wall with pilings that will extend a maximum of eight feet (8'), as shown on the drawings attached hereto and made a part hereof by reference, the receipt of which is hereby acknowledged, Temporary User agrees as follows:

- 1. Temporary User will defend, and hold harmless the City of Chattanooga, Tennessee, its officers, agents and employees from any and all claims for damages for injuries to persons or property related to or arising out of the aforementioned temporary use.
- 2. Temporary User will vacate the property and temporary use upon reasonable notice from the City to do so; the parties hereto agree that "reasonable notice" shall be deemed to be thirty (30) days. Temporary User will restore the property to its original condition when it is returned to the City.
- 3. Temporary User will provide adequate access for maintenance of any utilities located within the easement.
