A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF **CHATTANOOGA** TO ENTER INTO AN INTERLOCAL AGREEMENT, IN THE FORM ATTACHED HERETO, WITH HAMILTON COUNTY, TENNESSEE, FOR THE PURCHASE OF HOMELAND SECURITY EQUIPMENT FOR THE CHATTANOOGA FIRE DEPARTMENT AND THE CHATTANOOGA POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED THREE HUNDRED TEN THOUSAND NINE HUNDRED ONE AND 47/100 **DOLLARS** (\$310,901.47),WITH **HAMILTON** COUNTY GOVERNMENT REIMBURSING THE CITY OF CHATTANOOGA SECURITY GRANTS PROVIDED FROM HOMELAND HAMILTON COUNTY, TENNESSEE, BY THE UNITED STATES GOVERNMENT DURING FISCAL YEAR 2007-2008 WHICH SHALL BE COMPLETED BY APRIL 0F 2010.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Mayor of the City of Chattanooga be and is hereby authorized to enter into an Interlocal Agreement, in the form attached hereto, with Hamilton County, Tennessee, for the purchase of Homeland Security equipment for the Chattanooga Fire Department and the Chattanooga Police Department in an amount not to exceed \$310,901.47 with Hamilton County Government reimbursing the City of Chattanooga from Homeland Security Grants previously provided to Hamilton County, Tennessee, by the United States government during the fiscal year 2007-2008 which shall be completed by April of 2010.

INTERLOCAL AGREEMENT BETWEEN

THE CITY OF CHATTANOOGA

AND

HAMILTON COUNTY, TENNESSEE

WHEREAS, the parties to this Agreement are authorized to enter into an Interlocal Agreement for the mutual benefit of their respective citizens pursuant to T.C.A. § 5-1-113; and

WHEREAS, Hamilton County, Tennessee has agreed that it will reimburse the City of Chattanooga for certain purchases of approved Homeland Security training/equipment/supplies from Homeland Security Grants provided to Hamilton County, Tennessee by the United States government;

NOW, THEREFORE,

In consideration of the mutual covenants hereinafter stated, the City of Chattanooga and Hamilton County, Tennessee do hereby agree as follows:

- 1. Hamilton County, Tennessee shall reimburse the City of Chattanooga for the sum of Three Hundred Ten Thousand Nine Hundred One and 47/100 Dollars (\$310,901.47) following the City's purchase of approved Homeland Security training/equipment/supplies for the Chattanooga Fire Department totaling Three Hundred Fifty-Eight Thousand One Hundred Forty-Five and 25/100 Dollars (\$358,145.25), and the City's purchase of neighborhood watch signs for the Chattanooga Police Department totaling Two Thousand Seven Hundred Fifty-Six and 22/100 dollars (\$2,756.22). The purchases shall be completed by April of 2010.
- 2. The City of Chattanooga shall purchase the above Homeland Security training/equipment/supplies and neighborhood watch signs through normal bidding procedures for public purchases as required by the State law of Tennessee.
- 3. Following the purchase of the training/equipment/supplies and the neighborhood watch signs, the City of Chattanooga shall forward invoices and payments made by the City and request

reimbursement for payments made. The cumulative reimbursements by Hamilton County shall not exceed the amount of \$310,901.47.

- 4. Hamilton County agrees to reimburse the City of Chattanooga within fifteen (15) days after receipt of invoices for training/equipment purchases.
- 5. The parties agree that the terms of this Agreement are specifically enforceable in the event of a breach by either party. The parties agree that any action to enforce the terms of this Agreement shall be brought in the Chancery Court for Hamilton County, Tennessee and that any amendments to this Agreement during this term must be in writing and must be authorized by the legislative bodies of the City of Chattanooga and the Hamilton County Commission by resolution.
- 6. The parties agree that this Interlocal Agreement will be enforced and interpreted according to the laws of the State of Tennessee.
