BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That Greg Ross (hereinafter referred to as "Temporary User") be and is hereby permitted to use temporarily Rossville Avenue to install four (4) geothermal wells, as shown on the drawings attached hereto and made a part hereof by reference.

BE IT FURTHER RESOLVED, That said temporary usage shall be subject to the following additional conditions:

- 1. Temporary User shall be responsible for repairs to the existing sidewalk in the right-of-way due to the above-referenced installation and repairs must be done per City standards and code.
- 2. Temporary User shall, prior to any work in the right-of-way, contact the proper authorities (One Call) for the purpose of identifying any underground utilities.
- 3. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
- 4. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.
- 5. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.

## INDEMNIFICATION AGREEMENT

- 1. Temporary User shall be responsible for repairs to the existing sidewalk in the right-of-way due to the above-referenced installation and repairs must be done per City standards and code.
- 2. Temporary User shall, prior to any work in the right-of-way, contact the proper authorities (One Call) for the purpose of identifying any underground utilities.
- 3. Temporary User will defend, and hold harmless the City of Chattanooga, Tennessee, its officers, agents and employees from any and all claims for damages for injuries to persons or property related to or arising out of the aforementioned temporary use.
- 4. Temporary User will vacate the property and temporary use upon reasonable notice from the City to do so; the parties hereto agree that "reasonable notice" shall be deemed to be thirty (30) days. Temporary User will restore the property to its original condition when it is returned to the City.
- 5. Temporary User will provide adequate access for maintenance of any utilities located within the easement.




