A RESOLUTION AUTHORIZING THE CHIEF OF THE CITY OF CHATTANOOGA POLICE DEPARTMENT TO ENTER INTO A MEMORANDUM OF UNDERSTANDING, IN SUBSTANTIALLY THE FORM ATTACHED HERETO, WITH HAMILTON COUNTY, TENNESSEE, TO CO-HOST THE 17TH ANNUAL HOMICIDE CONFERENCE IN CHATTANOOGA, WITH THE CITY'S PORTION NOT TO EXCEED SIX THOUSAND DOLLARS (\$6,000.00).

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Chief of the City of Chattanooga Police Department be and is hereby authorized to enter into a Memorandum of Understanding, in substantially the form attached hereto, with Hamilton County, Tennessee, to co-host the 17th Annual Homicide Conference in Chattanooga, with the City's portion not to exceed \$6,000.00.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered into this _____ day of ________, 2008, between the City of Chattanooga, Tennessee (hereinafter "City"), and Hamilton County, Tennessee, (hereinafter "County"), hereinafter sometimes collectively referred to as the "Parties";

WHEREAS, said Parties along with the District Attorney's Office for the 11th Judicial District and the Regional Organized Crime Information Center (hereinafter "ROCIC") have agreed to host the 17th Annual Homicide Conference in Chattanooga, Tennessee on October 12, 2008 through October 15, 2008; and

WHEREAS, the ROCIC is an organization composed of criminal justice agencies in the southeastern and southwestern United States working together to combat multi-jurisdictional criminal activities; and

WHEREAS, the parties agree to provide payment as set forth herein for the location of the conference along with one catered dinner for the participants during the conference; and

NOW, THEREFORE, the Parties hereto, each in consideration of the promises and undertakings of the other as herein provided, do hereby agree as follows:

- 1. County agrees to enter into an agreement with a facility to accommodate the ROCIC conference to be held from October 12, 2008 through October 15, 2008.
- 2. County agrees to make arrangements for the catering of dinner for all participants of the conference on one evening during the conference.
- 3. Hosts agree that private vendors will be allowed to offer merchandise for sale during the conference and that County will be responsible for collecting any proceeds from all

vendor sales. Any proceeds collected by the County from vendor sales will be tabulated by County and used to off-set the total cost of facility rental and catering cost for dinner for the conference.

- 4. City agrees to pay to County at the conclusion of the conference an amount equal to one-half of the total cost of the facility rental and catering cost for dinner less any off-set for vendor sales. The parties agree that in no event shall the total monetary contribution of the City for the conference exceed SIX THOUSAND DOLLARS (\$6,000.00).
- 5. This Memorandum of Understanding may be terminated by any Party upon thirty (30) days' written notice to all parties.

IN WITNESS WHEREOF, the Parties hereto have caused their duly authorized representatives to execute this Memorandum of Understanding on their respective behalves on the date first written above.
