- 1. Planting and landscaping shall be subject to the City Traffic Engineer and the City Forester.
- 2. Temporary User is to verify the location (Tennessee One Call) of all underground utilities in the right of way to prevent damage.
- 3. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
- 4. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.

- 1. Planting and landscaping shall be subject to the City Traffic Engineer and the City Forester.
- 2. Temporary User is to verify the location (Tennessee One Call) of all underground utilities in the right of way to prevent damage.
- 3. Temporary User will defend, and hold harmless the City of Chattanooga, Tennessee, its officers, agents and employees from any and all claims for damages for injuries to persons or property related to or arising out of the aforementioned temporary use.
- 4. Temporary User will vacate the property and temporary use upon reasonable notice from the City to do so; the parties hereto agree that "reasonable notice" shall be deemed to be thirty (30) days. Temporary User will restore the property to its original condition when it is returned to the City.
- 5. Temporary User will provide adequate access for maintenance of any utilities located within the easement.
