

RESOLUTION NO. 26095

A RESOLUTION AUTHORIZING THE APPOINTMENT OF  
SPECIAL POLICEMEN (ARMED) FOR ERLANGER  
HOSPITAL SECURITY POLICE, TO DO SPECIAL DUTY AS  
PRESCRIBED HEREIN, SUBJECT TO CERTAIN  
CONDITIONS AND RESTRICTIONS

WHEREAS, Chattanooga City Code, Section 16-53, provides that upon written request of the supervisor of Erlanger Hospital security police, the Mayor may, with approval of the City Council, issue to members of Erlanger Hospital security police a special commission as police officer of the City providing such officers shall furnish a bond as is required of police officers of the City; and

WHEREAS, Erlanger Hospital has requested that the officers named herein be issued a police commission and the Mayor seeks approval of the City Council to issue such commissions.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That James William Cunningham, Roy Anderson Keown, Sydney Newton Hogsett, Ralph D. Ward, Lee Kenneth Snell, Michael Jerry Ball, Jerry Lee Lawrence, Gary Douglas Talley, Rodney Joseph Patton, Kevin J. Dossett, Kenneth Ray Cookston, Armando Andrew Lopez, Paul Leon Goins, Jr., William Stephen Holloway, Darryl Antonio Griffin, Matthew Shane Webb, Clinton Mark Haley, Michael D. Alderson, Leightaylor Noorbergen, Ronald J. Captez, Johnny Frazier, Gary C. Avans, Harold Holiday, Frank Newson, Sr., and Larry Benny Bush be and are hereby appointed as special policemen (armed) for Erlanger Health Systems, subject to the following conditions and restrictions:

1. That said special policemen shall have, possess and exercise every power, except as hereinafter limited, granted by the statutes of the State of Tennessee or the City of Chattanooga to regular police officers of the City of Chattanooga necessary in the performance of their duties. Such powers and performance of duties by said special policemen are expressly limited to the performance of duties in their position as Security Officers for Erlanger Health Systems.

2. That said special policemen shall not be considered employees of the Chattanooga Police Department, nor shall they be entitled to any benefits afforded regular police officers of the City, and shall in all respects be considered employees of Erlanger Health Systems.

3. That these special police commissions shall bear the endorsement "Erlanger Hospital Security Police Officer."

4. That such appointments shall expire upon termination of said special policemen's employment by Erlanger Health Systems. Notwithstanding any other provision herein, the City Council of the City of Chattanooga shall have the right to cancel such appointments at any time.
