BE IT FURTHER RESOLVED, That said temporary usage shall be subject to the following conditions:

- 1. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
- 2. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.
- 3. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.
- 4. Temporary User must meet with Traffic Engineering to insure canopies are placed as per City standards.
- 5. Any signage or banners attached to the structures must be permitted and approved by Traffic Engineering.





Temporary User shall restore the property to its original condition when it is returned to the City.
- 3. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.
- 4. Temporary User must meet with Traffic Engineering to insure canopies are placed as per City standards.
- 5. Any signage or banners attached to the structures must be permitted and approved by Traffic Engineering.






