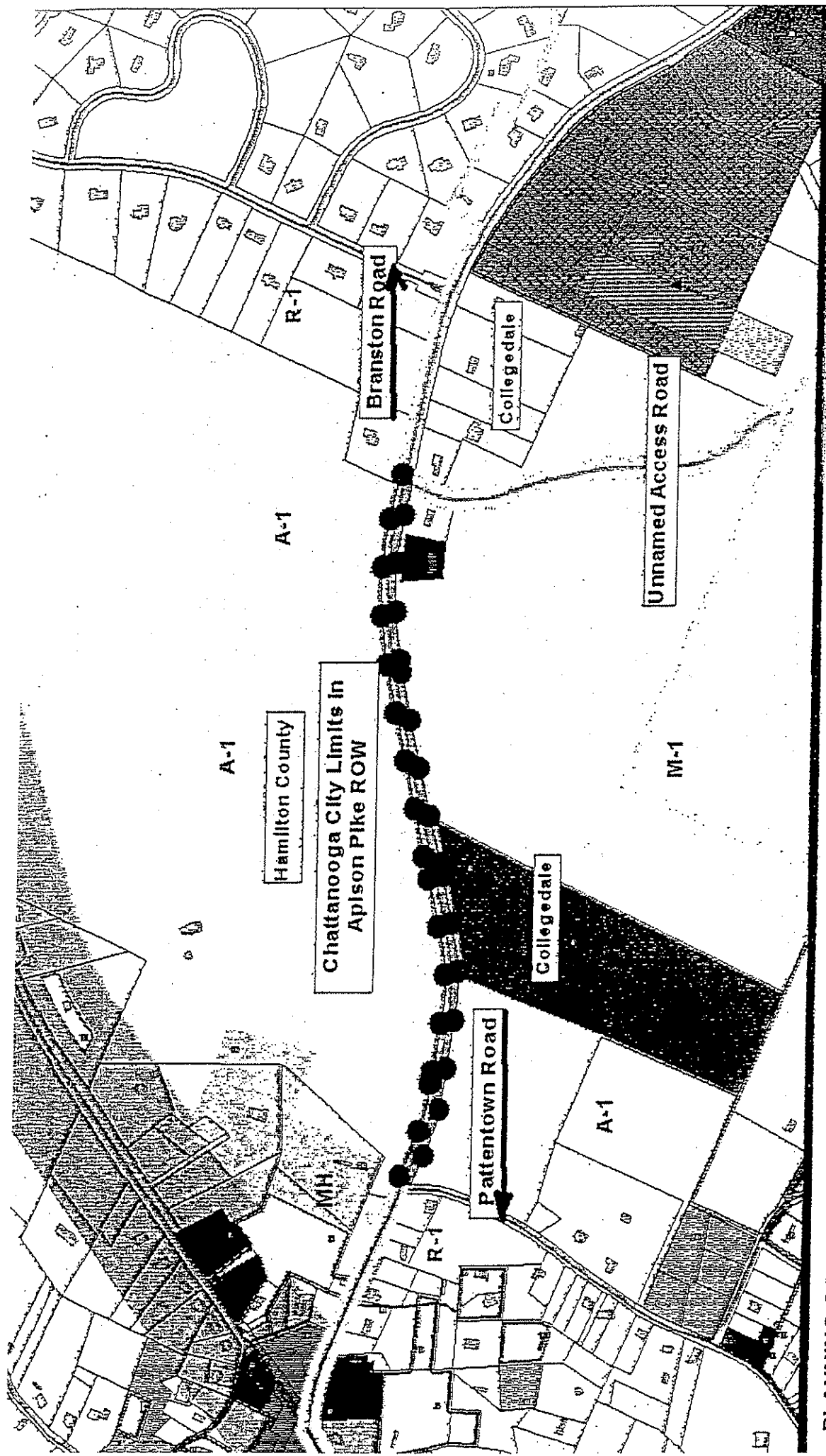
A RESOLUTION AUTHORIZING THE MAYOR TO SIGN AN INTERLOCAL AGREEMENT WITH THE CITY OF COLLEGEDALE TO ADJUST THE BOUNDARY ALONG 8300 THRU 8700 BLOCK OF APISON PIKE SO THAT IT WILL BE MAINTAINED AND BE INCLUDED IN THE CITY OF COLLEGEDALE.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Mayor be and is hereby authorized so sign an Interlocal Agreement with the City of Collegedale to adjust the boundary along 8300 thru 8700 block of Apison Pike so that it will be maintained and be included in the corporate boundaries of the City of Collegedale, more particularly described in the attached maps attached hereto.

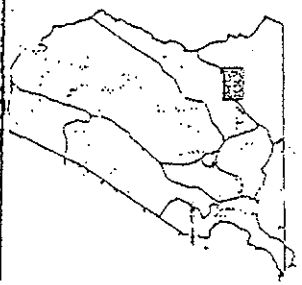
To provide a vacation/change in use of the street right-of-way of Apison Pike beginning on the south eastern corner of the right-of-way of Apison Pike at the intersection of Patten town Road and Apison Pike and following the southern boundary of the Apison Pike right-of-way until it meets the current city limits of the City of Collegedale at the eastern side of the right-of-way of an unnamed access road which is the current entrance to the Summit of Softball Park and the Summit Landfill; thence northbound following the City limits of the City of Collegedale to the northern right-of-way of Apison Pike; thence westward back to the current city limits of the City of Chattanooga at the intersection of Apison Pike and Patten town Road; and thence south to the point of beginning.

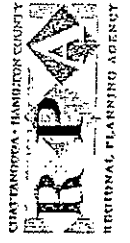
