A RESOLUTION AUTHORIZING TRANSFER OF THE CITY'S INTEREST IN CERTAIN PARCELS OF LAND AS MORE FORTH HEREIN. TO THE PARTICULARLY SET INDUSTRIAL DEVELOPMENT BOARD OF THE CITY OF CHATTANOOGA FOR INCORPORATION INTO THE LEASE WITH VOLKSWAGEN CHATTANOOGA OPERATION, LLC TO PROVIDE FOR ROADWAY AND RAILROAD RIGHTS-OF-WAY; TO CORRECT THE VOLKSWAGEN PROPERTY DESCRIPTION; AND AUTHORIZING THE INTERIM DIRECTOR OF GENERAL SERVICES TO EXECUTE ANY AND ALL DOCUMENTS RELATING THERETO.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That it is hereby authorizing transfer of the City's interest in certain parcels of land as more particularly set forth herein, to the Industrial Development Board of the City of Chattanooga for incorporation into the lease with Volkswagen Chattanooga Operation, LLC to provide for roadway and railroad rights-of-way; to correct the Volkswagen property description; and authorizing the Interim Director of General Services to execute any and all documents relating thereto.
