

RESOLUTION NO. 27265

A RESOLUTION AUTHORIZING HIXSON CHAMBER OF COMMERCE C/O MARV MARTIN TO USE TEMPORARILY THE RIGHT-OF-WAY OF FOUR (4) SEPARATE LOCATIONS TO INSTALL A SIGN LOCATED AT 6025 HIGHWAY 153, 5104 HIGHWAY 153, 3850 HIXSON PIKE, AND 506 ASHLAND TERRACE, AS SHOWN ON THE MAP ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That HIXSON CHAMBER OF COMMERCE C/O MARV MARTIN, (hereinafter referred to as "Temporary User") be and is hereby permitted to use temporarily the right-of-way of four (4) separate locations to install a sign located at 6025 Highway 153, 5104 Highway 153, 3850 Hixson Pike, and 506 Ashland Terrace, as shown on the map attached hereto and made a part hereof by reference.

BE IT FURTHER RESOLVED, That said temporary usage shall be subject to the following conditions:

1. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
2. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.
3. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.
4. The City of Chattanooga cannot grant the use of State right-of-way or private property for the placement of signage.

5. Temporary User must construct and place the welcome signs as per TDOT, FHWA, and City of Chattanooga standards.

6. Temporary User shall coordinate with the City of Chattanooga's Traffic Engineering Department for the placement of signage.

INDEMNIFICATION AGREEMENT

This Indemnification Agreement is entered into by and between THE CITY OF CHATTANOOGA, TENNESSEE (hereinafter the "City"), and HIXSON CHAMBER OF COMMERCE C/O MARV MARTIN (hereinafter "Temporary User"), this 2nd day of October, 2012.

For and in consideration of the granting of the temporary usage of the right-of-way of four (4) separate locations to install a sign located at 6025 Highway 153, 5104 Highway 153, 3850 Hixson Pike, and 506 Ashland Terrace, as shown on the map attached hereto and made a part hereof by reference, the receipt of which is hereby acknowledged, Temporary User agrees as follows:

1. Temporary User shall defend, and hold harmless the City of Chattanooga, Tennessee, its officers, agents and employees from any and all claims for damages for injuries to persons or property related to or arising out of the aforementioned temporary use.

2. Temporary User shall vacate the property and temporary use upon reasonable notice from the City to do so; the parties hereto agree that "reasonable notice" shall be deemed to be thirty (30) days. Temporary User shall restore the property to its original condition when it is returned to the City.

3. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.

4. The City of Chattanooga cannot grant the use of State right-of-way or private property for the placement of signage.

5. Temporary User must construct and place the welcome signs as per TDOT, FHWA, and City of Chattanooga standards.

6. Temporary User shall coordinate with the City of Chattanooga's Traffic Engineering Department for the placement of signage.

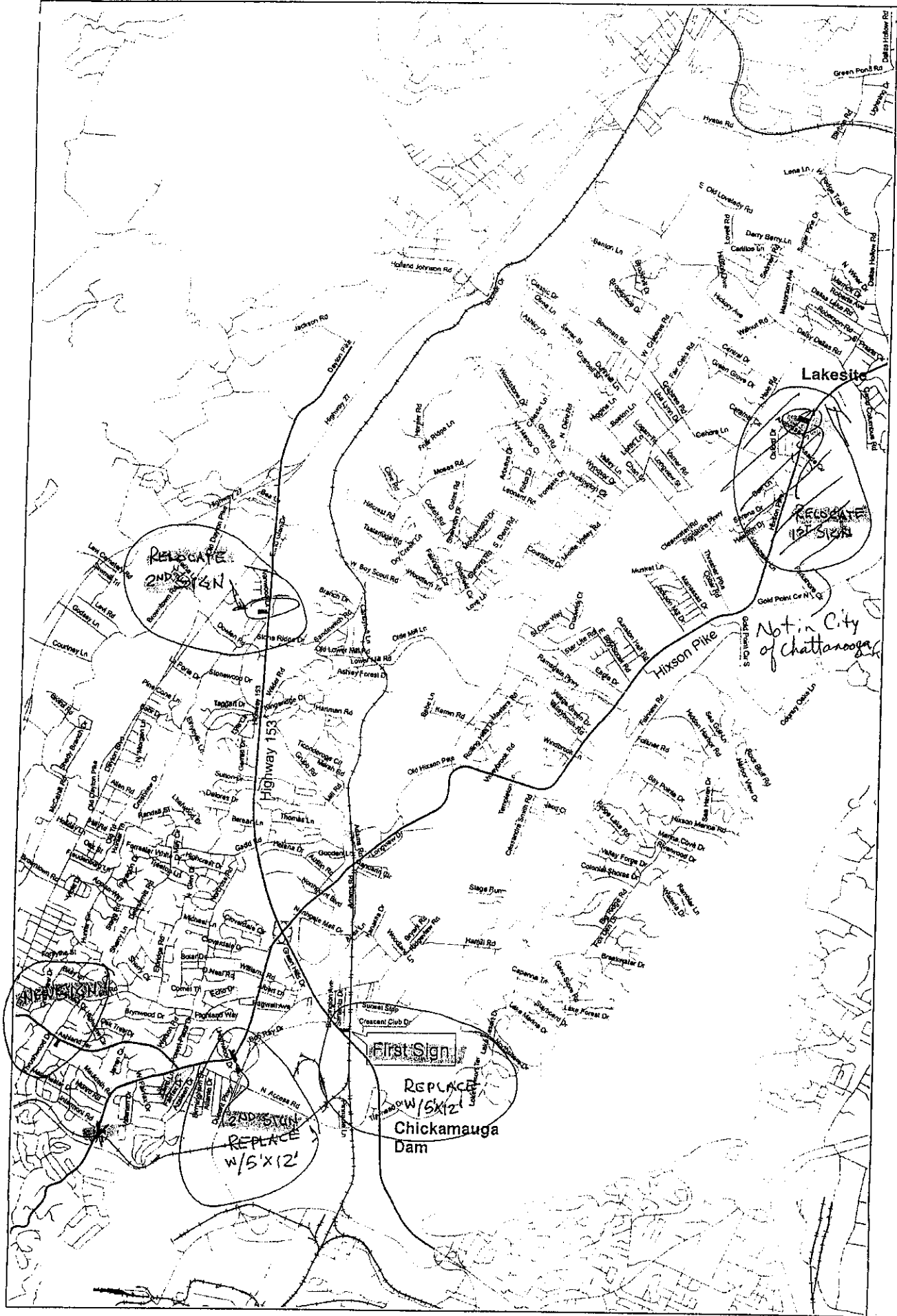
