RESOLUTION AUTHORIZING ALTON **PARK** DEVELOPMENT CORPORATION C/O ELENORA WOOD TO USE TEMPORARILY THE RIGHT-OF-WAY LOCATED AT 850 MARKET STREET FOR THE INSTALLATION OF A FREESTANDING HISTORICAL MARKER (RECOGNITION OF THE 1960 CIVIL RIGHTS SIT-IN AT NEARBY EATERIES) IN A PORTION OF THE SIDEWALK ADJACENT TO THE SOUTH SIDE OF THE **BUS** SHELTER AT INTERSECTION OF NORTH M.L. KING BOULEVARD, AS SHOWN ON THE DRAWINGS ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That ALTON PARK DEVELOPMENT CORPORATION C/O ELNORA WOOD, (hereinafter referred to as "Temporary User") be and is hereby permitted to use temporarily the right-of-way located at 850 Market Street for the installation of a freestanding historical marker (recognition of the 1960 Civil Rights sit-in at nearby eateries) in a portion of the sidewalk adjacent to the south side of the bus shelter at the intersection of North M.L. King Boulevard, as shown on the drawings attached hereto and made a part hereof by reference.

BE IT FURTHER RESOLVED, That said temporary usage shall be subject to the following conditions:

- 1. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
- 2. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.

# **INDEMNIFICATION AGREEMENT**

This Indemnification Agreement is entered into by and between THE CITY OF CHATTANOOGA, TENNESSEE (hereinafter the "City"), and ALTON PARK DEVELOPMENT CORPORATION C/O ELENORA WOOD (hereinafter "Temporary User"), this 5th day of February , 2013.

For and in consideration of the granting of the temporary usage of the right-of-way located at 850 Market Street for the installation of a freestanding historical marker (recognition of the 1960 Civil Rights sit-in at nearby eateries) in a portion of the sidewalk adjacent to the south side of the bus shelter at the intersection of North M.L. King Boulevard, as shown on the drawings attached hereto and made a part hereof by reference, the receipt of which is hereby acknowledged, Temporary User agrees as follows:

- 1. Temporary User shall defend, and hold harmless the City of Chattanooga, Tennessee, its officers, agents and employees from any and all claims for damages for injuries to persons or property related to or arising out of the aforementioned temporary use.
- 2. Temporary User shall vacate the property and temporary use upon reasonable notice from the City to do so; the parties hereto agree that "reasonable notice" shall be deemed to be thirty (30) days. Temporary User shall restore the property to its original condition when it is returned to the City.
- 3. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.
- 4. Any proposed items placed along the subject right-of-way must comply with ADA Standards and minimum clearances for pedestrian traffic within said right-of-way.


