RICHARDS, (hereinafter referred to as "Temporary User") be and is hereby permitted to use temporarily the portions of said right-of-way for the installation of up to fourteen (14) signs at thirteen (13) locations, as shown on the drawings and photos attached hereto and made a part hereof by reference.

BE IT FURTHER RESOLVED, That said temporary usage shall be subject to the following conditions:

- 1. Temporary User shall execute the Indemnification Agreement attached hereto in favor of the City of Chattanooga, its officers, agents and employees for any and all claims for damages for injuries to persons or property related to or arising out of the temporary usage.
- 2. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.
- 3. Temporary User shall provide adequate access for maintenance of any utilities located within the easement.

4. The proposed signage must meet the minimum requirements per City Codes and

Standards.

5. In the attached pictures, proposed locations for signs #11 and #12 appear to be on

private property. If that is the case, the City of Chattanooga is not giving permission for them to

be there; therefore, a signed agreement with each owner will need to be obtained and a copy

forwarded to the City Engineer.

6. For sign #5's location, the sidewalk area must be maintained.

7. For each sign location, the sight triangle must be maintained.
