

RESOLUTION NO. 28851

A RESOLUTION AUTHORIZING CHATTANOOGA ZOO C/O HANNAH HAMMON TO USE TEMPORARILY THE RIGHT-OF-WAYS LOCATED AT EAST THIRD STREET AND CENTRAL AVENUE; MCCALLIE AVENUE AND CENTRAL AVENUE; EAST THIRD STREET AND HOLTZCLAW AVENUE; AND MCCALLIE AVENUE AND HOLTZCLAW AVENUE, AS SHOWN ON THE MAPS ATTACHED HERETO AND MADE A PART HEREOF BY REFERENCE, SUBJECT TO CERTAIN CONDITIONS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That CHATTANOOGA ZOO C/O HANNAH HAMMON (hereinafter referred to as “Temporary User”) be and is hereby permitted to use temporarily the right-of-ways located at East Third Street and Central Avenue; McCallie Avenue and Central Avenue; East Third Street and Holtzclaw Avenue; and McCallie Avenue and Holtzclaw Avenue, as shown on the maps attached hereto and made a part hereof by reference.

BE IT FURTHER RESOLVED, That said temporary usage shall be subject to the following conditions:

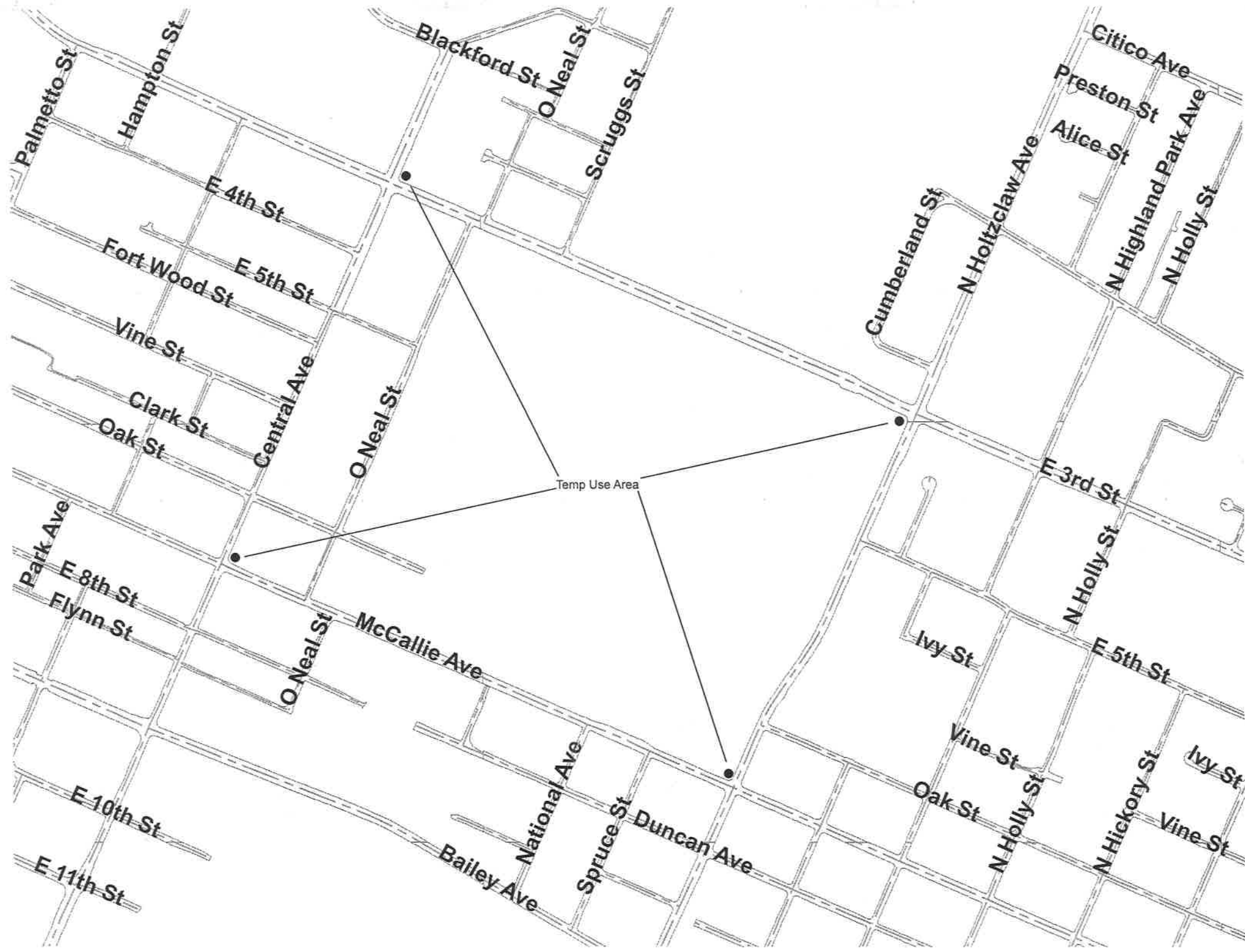
1. Temporary User may execute the Indemnification Agreement prior to the granting of a temporary use by the City Council provided that any obligation to Indemnify and hold the City of Chattanooga, its officers, agents and employees harmless for any claims for damages for injuries to persons or property shall be void if the Temporary Use is not granted to applicant by the Chattanooga City Council. Temporary User agrees to comply with all terms and conditions of the Indemnification Agreement in the event a temporary use is granted by the City Council.

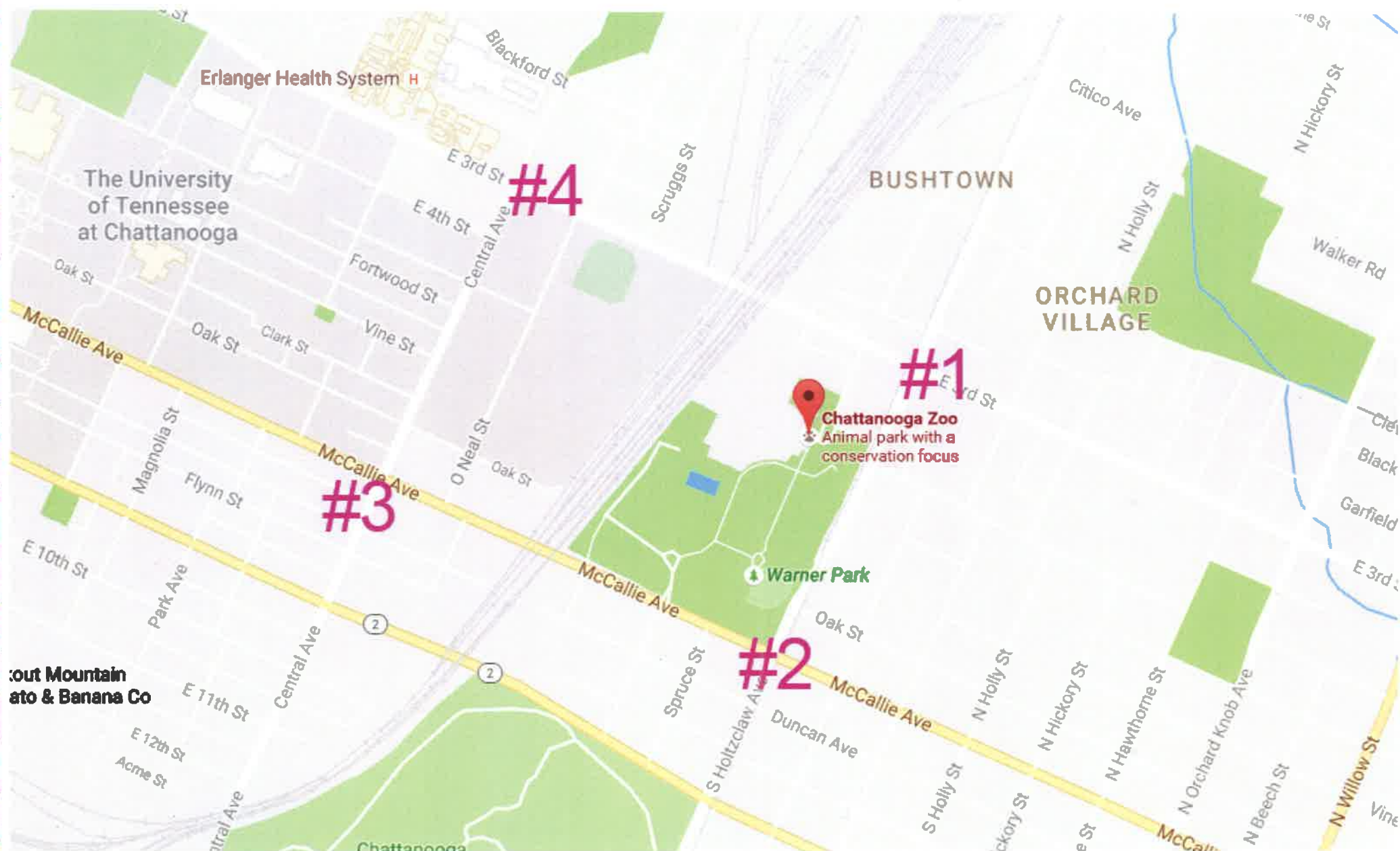
2. Temporary User agrees to vacate the property and temporary use upon reasonable notice from the City to do so.

3. Banners shall be attached to traffic signal poles or wooden utility poles with permission from the utility (ex. EPB, AT&T, etc.).
4. Banners shall have a maximum dimension of 72" x 31".
5. Reinforced grommets shall be provided on all four corners of the banners with 3/8" holes.
6. The material used for the banners shall be a heavy duty cloth, or an acrylic black-out vinyl with a minimum weight of 18 oz.
7. Banners shall be mounted a minimum of 12' above sidewalk.
8. Banners installed on steel poles must have 3/4" stainless steel 030 gauge banding and stainless or rust-proof brackets.
9. Banners installed on wood poles must use mounting brackets secured by lag bolts.
10. Installation of banners on 30' or higher street light poles is prohibited.
11. Temporary User shall obtain necessary permits and approvals from the City of Chattanooga Land Development Office.
12. Temporary User shall provide adequate access for maintenance of any utilities located within the easement, is responsible for verifying all utility locations within the subject area prior to initiating the agreed usage, as well as the protection of said utilities for the duration of this permit.
