A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE DEPARTMENT OF YOUTH AND FAMILY DEVELOPMENT AND INITIATED BY THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, TO EXECUTE AN AGREEMENT TO EXERCISE OPTION TO RENEW WITH CHATTANOOGA HOUSING AUTHORITY, IN SUBSTANTIALLY THE FORM ATTACHED, FOR A TERM OF ONE (1) YEAR FOR THE USE OF THE GYMNASIUM AT CROMWELL HILLS APARTMENTS TO OPERATE PROGRAMS FOR YOUTH, YOUNG ADULTS AND FAMILIES ON THE PROPERTY LOCATED AT 3940 CAMELLIA DRIVE ON A PORTION OF TAX PARCEL NO. 137E-A-001.
