A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE DEPARTMENT OF YOUTH AND FAMILY DEVELOPMENT AND INITIATED BY THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, TO EXECUTE AN AGREEMENT TO EXERCISE OPTION TO RENEW WITH CHATTANOOGA HOUSING AUTHORITY, IN SUBSTANTIALLY THE FORM ATTACHED, FOR A TERM OF ONE (1) YEAR FOR THE USE OF THE SHEILA JENNINGS WELLNESS CENTER TO OPERATE PROGRAMS FOR YOUTH, YOUNG ADULTS AND FAMILIES ON THE PROPERTY LOCATED AT 1201 POPLAR STREET ON A PORTION OF TAX PARCEL NO. 145F-A-002.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That the Mayor is hereby authorized on behalf of the Department of Youth and Family Development and initiated by the Department of Economic and Community Development, to execute an Agreement to Exercise Option to Renew with Chattanooga Housing Authority, in substantially the form attached, for a term of one (1) year for the use of the Sheila Jennings Wellness Center to operate programs for youth, young adults and families on the property located at 1201 Poplar Street on a portion of Tax Parcel No. 145F-A-002.
