## RESOLUTION NO. 29829

A RESOLUTION AUTHORIZING SETTLEMENT OF ALL CLAIMS BY MARK SMELTZER, TOBY HEWITT, AND NEALIE HOGG, ET AL (CLASS ACTION PARTIES REFERENCED BELOW), SUBJECT TO THE EXECUTION OF A RELEASE OF ALL CLAIMS AND DISMISSAL, WITH PREJUDICE, OF THE CITY OF CHATTANOOGA AND WHEREIN THE CITY OF CHATTANOOGA WILL SETTLE ALL POLICE PAY CLAIMS OF THE LISTED NAMED THIRTY-ONE (31) POLICE OFFICERS, IN THE TOTAL AMOUNT OF FOUR HUNDRED FIFTY-FOUR THOUSAND FOUR HUNDRED FIVE AND 50/100 DOLLARS (\$454,405.50).

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, That it is hereby authorizing settlement of all claims by Mark Smeltzer, Toby Hewitt and Nealie Hogg, et al (as class action representatives of the parties referenced below), subject to the execution of a Release of All Claims and dismissal, with prejudice, of the City of Chattanooga in the case styled, *Mark Smeltzer*, et al. v. City of Chattanooga, et al., Hamilton County Chancery Court Docket No. 16-0621, and upon satisfaction of the conditions, wherein the City of Chattanooga will settle all back pay and retirement claims of the listed named thirty-one (31) police officers as potential class members, in the total settlement amount of \$454,405.50.
