RESOLUTION NO. 29858

A RESOLUTION AUTHORIZING THE REDEMPTION OF CERTAIN CITY OF CHATTANOOGA, TENNESSEE GENERAL OBLIGATION BONDS

WHEREAS, the City issued its \$6,840,000 General Obligation Bonds, Series 2010C (Recovery Zone Facility Bonds) on March 5, 2010 (the "Bonds");

WHEREAS, there remains unspent \$3,285,972.81 of the proceeds of the Bonds;

WHEREAS, the City Council has determined it is in the City's best interest to use the unspent proceeds from the Bonds to redeem certain maturities of the Bonds; and

WHEREAS, the City Council desires at this time to redeem certain maturities of the Bonds, as more fully described below.

NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE:

SECTION 1. That the redemption of certain maturities of the City's outstanding General Obligation Bonds Series 2010C (the "Redeemed Bonds") is hereby authorized, and that the Mayor and/or City Finance Officer are hereby authorized to proceed herewith; that the specific maturities of the Redeemed Bonds to be redeemed shall be determined by the Mayor and/or City Finance Officer and set forth in a certificate.

SECTION 2. That the City hereby authorizes publication, in the name of the City, as soon as practicable, a notice of redemption of the Redeemed Bonds in accordance with the redemption provisions of the Redeemed Bonds as set forth in the resolutions of the City authorizing the issuance of such bonds.

SECTION 3. A portion of the unspent proceeds from the Bonds shall be used for the

purpose of paying the Redeemed Bonds.

The Mayor and City Finance Officer are hereby authorized to execute SECTION 4.

such documents, instruments and papers, to open such bank accounts or custodian accounts, and

do such acts as may be necessary or advisable in connection with the authorization and security

for the redemption of the Redeemed Bonds.

The Mayor and City Finance Officer are hereby authorized and SECTION 5.

empowered to execute and deliver, or cause to be executed and delivered such other documents

and opinions, and to do all such acts and things as may be necessary or desirable in connection

with the redemption of the Redeemed Bonds.
