A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE THE SECOND AGREEMENT TO EXERCISE OPTION TO RENEW WITH THE HOUSE OF RUTH, INC., IN SUBSTANTIALLY THE FORM ATTACHED, FOR PARCELS LOCATED AT 167C-B-015, 167C-B-016, AND 167C-B-017, WITH ASSIGNED ADDRESSES OF 4327 OAKLAND AVENUE, 4333 OAKLAND AVENUE, AND 511 W. 45<sup>TH</sup> STREET, AT THE RATE OF ONE DOLLAR (\$1.00) PER YEAR, FOR AN ADDITIONAL TERM OF ONE YEAR, WITH THE PARKING TO BE USED BY THE MEMBERS OF THE GREATER ST. JOHN MISSIONARY BAPTIST CHURCH AND FOR CHARITABLE PURPOSES AS AUTHORIZED BY THE LESSEE'S BOARD OF DIRECTORS.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHATTANOOGA, TENNESSEE, that it is hereby authorizing the Mayor to execute the Second Agreement to Exercise Option to Renew with the House of Ruth, Inc., in substantially the form attached, for parcels located at 167C-B-015, 167C-B-016, and 167C-B-017, with assigned addresses of 4327 Oakland Avenue, 4333 Oakland Avenue, and 511 W. 45<sup>th</sup> Street, at the rate of \$1.00 per year, for an additional term of one year, with the parking to be used by the members of the Greater St. John Missionary Baptist Church and for charitable purposes as authorized by the Lessee's Board of Directors.
